Advanced Training short course – Channel Research


Channel Research is pleased to announce **the third advanced seminar-based training on 'ADVANCED EVALUATION OF HUMANITARIAN ACTION' (EHA)**, facilitated by **Margie Buchanan-Smith** and **John Cosgrave**.

It will take place near Brussels from **Thursday 30 May, to Friday 31 May 2012** inclusive. Participants are expected to arrive on Wednesday evening at the welcome dinner and depart on Friday early evening.

The full price for the session is **1,350 €** (not including 21% VAT), including transport from Brussels airport or the station 'Brussels Midi' to the course venue, the training itself and materials, seminar facilities, refreshments, accommodation and meals from Wednesday evening until Friday late afternoon. An **early booking reduction of 100 €** will be provided for those participants who pay before 15 April. There are 2 places available for independent consultants not sponsored by an organisation at a reduced training fee of 1150 € (not including 21% VAT). The maximum number of participants is 15.

This advanced training will be based on the participants' own experience, and will therefore be conducted in a seminar-like style. The trainers will work to facilitate learning by the participants and will provide information, examples and links to external resources, exploring some of the cutting-edge issues in EHA, such as 'remote evaluation'

This training will draw on the **new**  **guide on 'Evaluating Humanitarian Assistance'**, co-authored by Margie Buchanan-Smith and John Cosgrave, and currently being piloted. The theme of evaluation utilisation will be central to the whole programme. Participants are invited to reflect on issues and challenges they have faced in their own evaluation experience, as well as examples of good practice, and to bring them to the course. There is considerable flexibility built into the schedule which means that it can be adapted to meet the particular learning needs, evaluation issues and concerns brought by the participants.

This advanced training on evaluating humanitarian action is intended for experienced evaluators and evaluation managers. Participants from the introductory training are expected to gain extensive

evaluation experience before they attend the advanced module, unless they already have extensive evaluation experience.

This session will draw on participants' experience to develop general lessons for these two challenging evaluation types, and will draw on the trainers' experience.</p>

This session will use a coaching style to resolve issues that participants have faced, in developing robust and well-grounded conclusions and recommendations, and in disseminating them.</p>	Wrap-up and closure at 16:00

19:00	<p><b>Evaluation problems panel:</b> Thursday Evening. The trainers will try (with the help of participants) to suggest solutions to evaluation problems posed by the participants during a leisurely working dinner. This is an opportunity for exchange of opinions and amongst participants.</p>
