# Evaluation of Humanitarian Action (EHA) Training Workshop



GRM International in association with Channel Research will be hosting the annual 3 day Evaluation of Humanitarian Action (EHA) training workshop in Geneva from 9 - 11 June 2015. This will be the 8th year of running this training workshop which has proved invaluable for engaging and networking with colleagues from the humanitarian community.

The aim of the training workshop is to make evaluations more effective in contributing to the improved performance of humanitarian interventions and to enhance the quality of the evaluation process. This course is recommended for evaluators, managers and users of evaluations. Previous evaluation experience is not necessary, but some knowledge and experience of humanitarian action is required.

The course is facilitated by highly experienced evaluators and trainers, Margie Buchanan-Smith and John Cosgrave, who also co-authored the ALNAP guide. (Active Learning Network for Accountability and Performance in Humanitarian Action (ALNAP).
